## **CHATEAU FORET POOL RULES**

- Pool hours are: 9:00 AM to 10:00 PM. Pool use at any other time constitutes *trespassing*. Violators will forfeit their *access-card* and pool privileges if found trespassing.
- During operating hours the pool gate is locked. *Gate must not be propped open*. Non-compliance *will* result in the forfeiture of *access-card*, loss of pool privileges and/or closure of the pool.
- GUESTS USE : <u>Guests must be accompanied by the resident at all times</u>. Residents may not loan pool <u>access-cards</u> to Guests. All guests are subject to Association rules; if guests violate the rules, the owner/resident is responsible and their pool use privileges will be forfeited.
- **PERSONAL HYGIENE**: A bather using the pool <u>must</u> shower before entering the pool area. Any bather who has known skin conditions and /or open sores, may not enter the water.
- NO one under the age of <u>14</u> is allowed in the pool area at any time, unless accompanied by their parent or legal guardian, <u>who must be an Owner or resident</u>.
- NO GLASS CONTAINERS OF ANY KIND ARE ALLOWED IN POOL AREA.
- NO FOOD, ALCOHOL, SMOKING: allowed within the pool area.
- NO ANIMALS (Service animals are exempt) and if necessary allowed within the pool area.
- DRESS CODE: Swimming suits are required No cut offs or underwear are allowed in the pool. Swimming diapers are required to be worn by infants and toddler under the age of 3. Regular diapers are not allowed in the pool at any time.
- **BLOCKING GATE OPEN IS STRICTLY PROHIBITED!** Do not open the pool gate for anyone without an *access-card*, unless the individual is a member of your household or your personal guest.
- YOU MUST CLEAN UP AFTER YOURSELF AT THE POOL: Garbage and other debris are unhealthy and may mandate closure of the pool.
- The pool area is not available to be reserved for private parties!
- COST OF REPLACEMENT and REACTIVATION FEE of ACCES-CARDS: \$50.00.
  <u>Access-cards</u> are registered to Unit Owner by name and address and will be <u>de-programmed</u> if abused or lost <u>and/or if Unit Owner is in default of assessments</u>! When Owner(s) become current there will be a \$50.00 access-card reactivation fee.

## IN CASE OF AN EMERGENCY CALL 911

Violations of the listed pool rules will result in fines and penalties being imposed and pool access privileges, including registered pool access-cards will be forfeited until fines and penalties are paid current and violations cease.
